#### 4. The implications of COVID-19-19 for Healthwatch Brighton and Hove

David gave overview

#### Where we are in the city with COVID

- Brighton moved from Yellow to Amber, the second tier in a 4 tier system government changing the protocol to a 3-tier system, Brighton is likely to be in the lowest Tier 1
- David to try and get some more accurate figures to the board there will be more accurate figures in the next bulletin
- David will let the board know if there is anything that they need to be aware of

#### **Engaging with the local community**

• At the start of the pandemic Healthwatch across Sussex had been asked if we wanted to work within the Gold/Silver/Bronze COVID response committee system – we declined on the basis that this was primarily a service providing response and our statutory function is in assurance and independent challenge. We recognized at that early stage that Healthwatch Brighton and Hove might do more by way of helping signpost people to services and to provide independent updates on the COVID response. By taking that independent position we secured a weekly briefing with the NHS Gold Commander for COVID, Adam Doyle – these briefings have been used very effectively to escalate issues of concern including PPE, Care Home safety and Care home visiting, End of Life Care, Dental Care, water and sanitation for Travelers and Van Dwellers, Digital Disadvantage, access to Primary Care, Communications on planned care and cancer, plans to return

the NHS to pre COVID levels of activity, hospital discharge support, future demand for emotional support and mental health care including self-harm and suicide. have been dropped to fortnightly and will probably go down to monthly

- Meetings with Lola Banjoko, MD of the B&H CCG and Rob Persey have been established fortnightly
- Health and Wellbeing Board and HOSC B&H returned to full operation in July 20

#### Operational

- -Healthwatch B&H continue to be fully operational but with some projects amended and some new projects notably: Hospital Discharge Wellbeing Project [HOPs], RoaR – COVID restore and Recovery Programme commissioned Sussex wide by the NHS, comprising three projects, Digital Solutions in the response to COVID, Care Home support for relatives, Hospital Discharge [patient engagement], Review of Patient Transport Services, Mental Health Sector Connector Project linking the NHS, Local Authorities and Voluntary Sector Providers.
- -Healthwatch B&H is n ow working much more remotely and digital based

#### Workplan

- HOPs backlog has gone new volunteers now joined Fran will be Board Sponsor
- Home Care linked to HOPs a project to reach out to 85 people who voluntarily gave up their Home Care packages during COVID 1<sup>st</sup> lockdown – this has now been completed
- COVID Updates Very positive feedback, produced weekly initially and more recently fortnightly
- Mental Health Sector Connector Next Forum Sussex wide will be in Late Nov'/early
  December 20 focusing on remote consultations
- ROAR programme of work is ongoing and expected to be completed before Christmas
